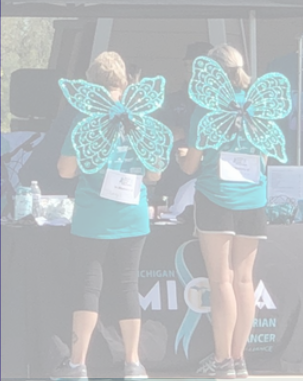

During 2019, MIOCA advanced its mission to improve the health and quality of life for women and girls with ovarian cancer throughout the state of Michigan by focusing on **Awareness, Education, Survivor Support, Advocacy and Research.**

AWARENESS AND EDUCATION

EDUCATING FUTURE HEALTH PROFESSIONALS

1,011 FUTURE HEALTHCARE PROFESSIONALS

As statewide facilitators of the Survivors Teaching Students: Saving Women's Lives® Program of the Ovarian Cancer Research Alliance, MIOCA teams educated 1,011 future healthcare professionals (medical, nursing, or other allied health professional students) at 10 schools throughout Michigan.



PUBLIC EVENTS

5,372 INDIVIDUALS PARTICIPATED

Over 5,300 individuals participated in awareness-raising events throughout the state including Wheels and Teal, Shake Your Teal Feathers, Ann Arbor Mother's Day Run, Tie Michigan Teal, Teal Attack, and golf outings.



PROGRAMS AND OUTREACH

Through outreach programs including survivor days, lunch and learns, and its SPEAK (Survivors Promoting Early Awareness and Knowledge) program, MIOCA reached community members in **churches, hospitals, and community centers throughout the state** including Detroit, St. Claire Shores, Ann Arbor and Saginaw.

Survivor Support Totes containing gifts and helpful information for women in treatment **were distributed to 86 ovarian cancer survivors** across Michigan.

Over **50** survivors participated in 2019 MIOCA Meet and Greets for a day of sharing and support



MIOCA helped facilitate **3 monthly support groups** in Ann Arbor, Grand Rapids and Traverse City to ensure women throughout the state have access to a network of community support.

ADVOCACY

Representing ovarian cancer survivors from across the state, MIOCA works to advance federal and state legislation to improve funding and support for survivors. MIOCA speaks as the voice of survivors educating legislators about the public policy initiatives critical to saving lives from ovarian cancer. In March 2019, **a delegation of 10 MIOCA representatives traveled to Washington, D.C.** to join almost 100 advocates at the National Ovarian Cancer Advocacy Day, coordinated by our national partners at the Ovarian Cancer Research Alliance.

The MIOCA team included six ovarian cancer survivors and two caregivers, five of whom received a MIOCA Advocacy scholarship to support their participation. Following a day of advocacy training, our team visited our two Michigan Senators and eight of our Representatives to advocate for increased funding for ovarian cancer research and education, including:

\$6.5 BILLION FOR THE NATIONAL CANCER INSTITUTE

\$9.5 MILLION FOR THE OVARIAN CANCER CONTROL INITIATIVE AT THE CDC

\$12 MILLION FOR JOHANNA'S LAW AT THE CDC

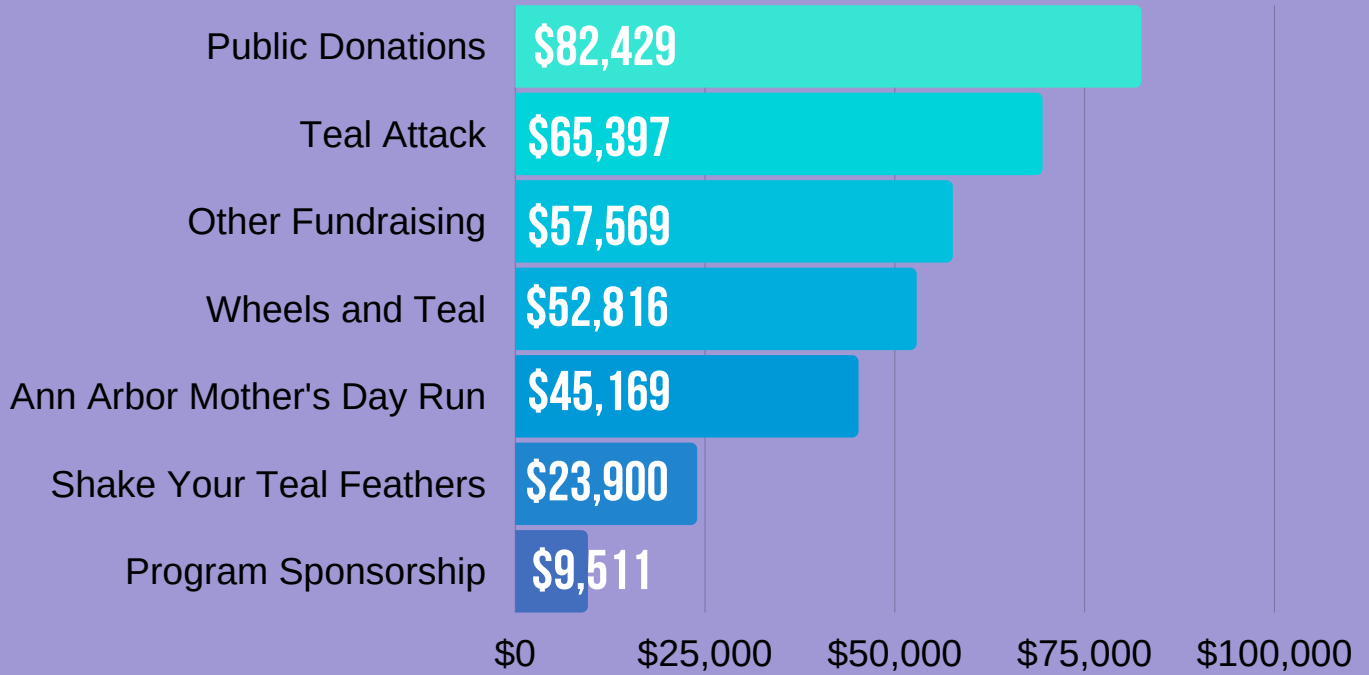

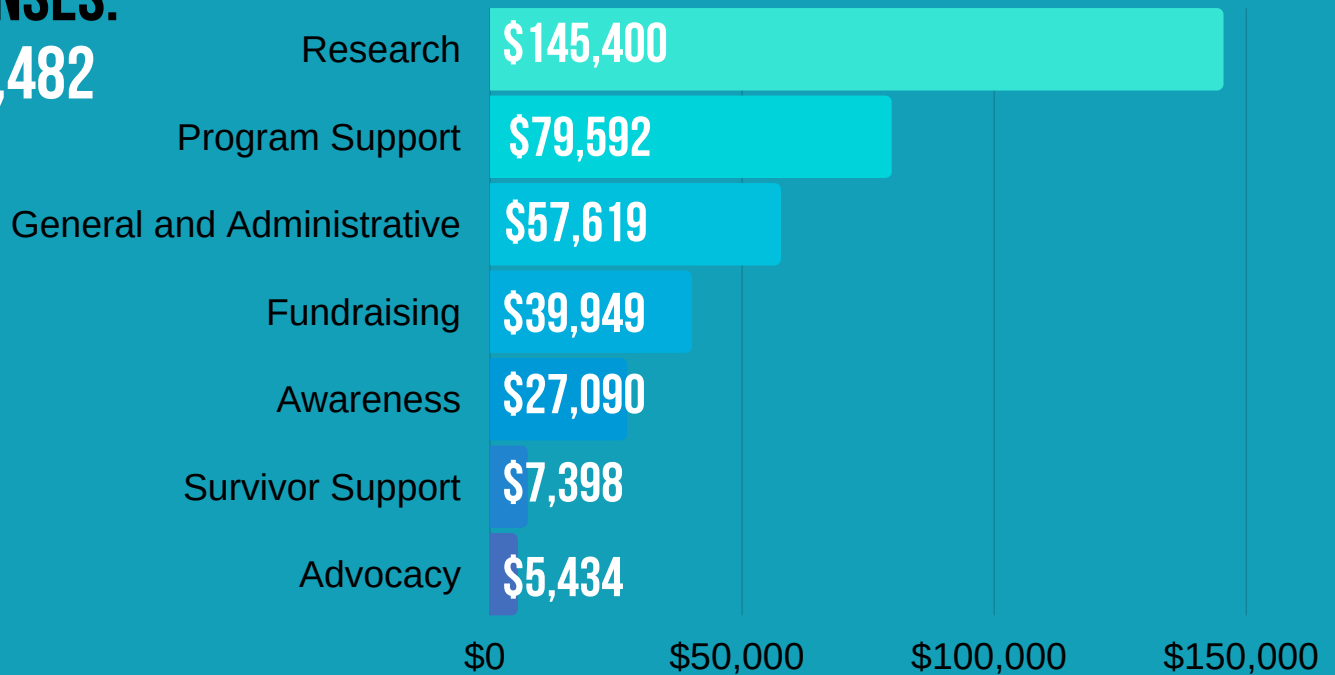
